Re-Sitting Form is to be filled by the student in his/her own hand writing in English, using black ball point pen very carefully in Block Letters only.</li> <li>2. The address of the student must be complete in all respect. It is compulsory to mention PIN Code, Telephone/Cell No. and e-mail address (if any).</li> <li>3. The Form having overwriting, striking out or erasure of any kind is liable to be rejected.</li> <li>4. The Re-Sitting Form provided by the University for the examination to be held in July-August 2010 will only be accepted.</li> <li>5. Separate Form (for each Semester/Year) is to be filled by the student along with the separate Demand Draft.</li> <li>6. The Re-Sitting Examination fees is to be paid by demand draft in favour of DDE, AAI-DU, A/c payable at Allahabad. Re-Sitting Fees: (a) One Paper Rs. 200/- (b) Two Papers Rs. 400/- (c) More than Two Papers of a Semester Rs. 500/- only. (d) More than Two Papers of a Year Rs. 600/- only.</li> <li>7. To avoid the clashing of Re-Sitting Exam with Regular Exam, this has been implemented that students who are in even number Regular Semester/Year will allowed to appear in Re-Sitting Exam of the papers of odd Number Semester/Year and vice-versa. Violating this, the Re-sitting form will be rejected.</li> <li>8. If the student fills Re-Sitting forms of two previous Semesters/Years, then in the event of clashing of such Semesters/Years, the Re-Sitting form shall be accepted for the previous most Semester/Years only.</li> <li>9. Forms filled for improvement shall not be accepted.</li> <li>10. Fees once paid will neither be refunded nor adjusted.</li> <li>11.
